


2023-2024 Cycle Summary

The NursingCAS Data Report provides an overview of key information and helps identify profession-wide trends within nursing admissions. This release marks the first annual report and focuses on the 2023-2024 cycle, which includes the following matriculation terms: Summer 2024, Fall 2024, Winter 2025, and Spring 2025.


Applicant-related data only includes submitted applications received through the Nursing Centralized Application Services (NursingCAS).

Participating Schools by Cycle




NursingCAS saw a 4% decrease in participating schools (schools that successfully went live and accepted applicants) in the 2023-2024 cycle in the wake of implementing the exclusivity requirement. Despite the decrease in participating schools, the number of submitted applicants and submitted applications increased, exceeding prepandemic numbers.

Compared to the 2022-2023 cycle, submitted applicants increased by 21% and submitted applications increased by 25%. With 64,443 applicants and 90,765 submitted applications, this has been the most successful NursingCAS cycle to date!

Schools & Programs

AACN's NursingCAS continues to expand. In the 2023-2024 cycle, 31 new schools joined the NursingCAS community. AACN is committed to having full participation of nursing schools in NursingCAS to provide discipline-wide data on enrollment trends.




Participating School Data

NursingCAS Virtual Fair


86 schools (32% of NursingCAS schools) participated in the 2023 Discover Nursing School Virtual Fair. This live, online event is exclusive to NursingCAS schools and allows programs to meet with prospective students in their own personalized chat rooms. Schools engaged with 2,269 student registrants (a 48% increase from the previous year), representing 48 states and 43 countries.




NursingCAS Applicant Newsletter

80 schools (30% of NursingCAS schools) made **382 submissions** to the <u>NursingCAS Applicant Newsletter</u> in the 2023-2024 cycle. This monthly publication allows schools to advertise open seats, deadline extensions, and new programs to the NursingCAS applicant pool.




Applicant Events Calendar

63 schools (23% of NursingCAS schools) made **738 submissions** to the <u>NursingCAS Applicant Events</u> <u>Calendar</u> in the 2023-2024 cycle. This tool allows schools to advertise student information sessions, virtual fairs, open houses, and other recruitment events to the NursingCAS applicant pool.



Analytics by Liaison

157 schools (58% of NursingCAS schools) use <u>Analytics</u> <u>by Liaison</u>, a Tableau-based dashboard that pulls data from NursingCAS and allows programs to track year-over-year data points with accompanying infographics.



Echo Targeting

28 schools (10% of NursingCAS schools) use <u>Echo</u>
<u>Targeting</u>, a digital banner advertising tool that allows member schools to exclusively reach NursingCAS students while they surf the internet.

In the 2023-2024 cycle, White students made up the highest percentage of applicants (43% of total applicants), followed by Hispanic (21%), Black/African-American (17%), and Asian applicants (12%).

The total percentage of Black/African-American applicants increased by 1% from the 2022-2023 cycle, while White applicants decreased by the same amount.

Applicant Age Distribution

Applicants in the 2023-2024 cycle broke down along the following lines:

• Under 19: **7.4%**

• 27-28: **7.4%**

• 19-20: **17.4%**

• 29-30: **6.0%**

• 21-22: **7.2**%


• 31-25: **10.9%**

• 23-24: **6.5%**

• Over 35: 15.8%

• 25-26: **6.4%**

The **19-20 age bracket** saw the **highest volume of applicants**, followed by the over 35 bracket.

Applicant Gender

In the 2023-2024 cycle, applicant gender demographics reflected long-standing trends of a predominantly female discipline.

- 82% of applicants were female a decrease of 1% compared to the 2022-2023 cycle figures.
- 17% of applicants were male no change from the 2022-2023 cycle figures.
- 1% of applicants declined to state their gender a fraction of a percent increase from the 2022-2023 cycle figures.

NursingCAS Fee Waiver Utilization

100%

100% of NursingCAS Fee Waiver funding was utilized in the 2023-2024 cycle to support prospective nursing students. 1,063 fee waivers were provided to offset the cost of an applicant's first application.


Fee Waivers were turned off in February 2024 after all available funding was exhausted. AACN provided more than \$60,000 in waivers to support this NursingCAS initiative.

NursingCAS receives tens of thousands of applicants from across the globe. Below are some statistics on the demographic backgrounds of our 2023-2024 cycle applicants.

United States & U.S. Territory Applicants



California yielded the highest number of applicants in the 2023-2024 cycle, followed by Texas, Florida, New York, and Illinois. NursingCAS received applicants from all 50 U.S. states, the District of Columbia, Puerto Rico, Guam, the U.S. Virgin Islands, and the Northern Mariana Islands.



NursingCAS also received nearly 3,800 applicants from across 155 foreign countries. The countries with the greatest number of applicants in the 2023-2024 cycle were:
